Public Hearing and Regular Meeting of December 5, 2019 of the Board of Education. School District 27 was called to order at 6:30 p.m. in the Wood Oaks Library, in said district.

Mrs. Melnick called the meeting to order.

## Public Hearing

Mrs. Melnick declared the Public Hearing for the 2019 Tax Levy open.

Dr. Arakelian presented on the Northbrook School District 27 2019 Tax Levy, an overview of the District's history on the tax levy, and the tax rate. Dr. Arakelian reported that on November 5, 2019, the Tentative Tax Levy was reviewed; on November 21, 2019 a recommendation was made to adopt the 2019 Tax Levy was approved; and this evening, December 5, 2019 the Public Hearing is being held. A recommendation to approve the Northbrook School District 27 Tax Levy will be made at the December 19, 2019 Board meeting. The increase is tied directly to the 2018 Consumer Price Index (CPI) of 1.9% which will generate approximately \$516,000 of additional revenue, plus an additional 2.05% for new property and redevelopment. The total Levy is a 3.95% increase over the prior year aggregate extension. The total Levy in dollars is \$28,237,696.

The Board and Administration also reviewed the District's long-range financial projection through fiscal years 2018-23. The District is currently in a stable financial position with a 75% level of cumulative fund balance reserve; and working toward increasing this balance, seeking to both meet our Board policy target and have additional funds for major capital improvement projects. The good news with the current financial projection is that the District will continue to grow in fund balance reserve. However, we will need to continue to monitor key economic factors that could impact the District from a financial

perspective. Factors such as the State budget, property tax freeze, cost of pension obligations shifting to employers and the Affordable Care Act.

Mrs. Melnick asked if there were any comments from the Board members on the Tax Levy. There were none.

Mrs. Melnick asked if there were any further community comments and there were none, and Mrs. Melnick announced the Public Hearing on the 2019 Tax Levy closed.

### Board Reports

Mrs. Copeland reported on the Illinois Association of School Boards Joint Annual Conference that she attended on Saturday, November 23, 2019. She attended the Delegate Assembly to make a statement on behalf of the Board of Education on the Resolution that would provide local school boards the option to decide if they would allow properly trained staff to be armed in school buildings as part of the districts' student safety protection plans. The Resolution was not adopted, as the voting was 198 in favor and 249 against. The rural southern districts were largely in favor of the Resolution.

The goal is to provide a positive culture in the school through a systematic approach to support students with resources so they can thrive in our schools. He reported on the three tiers of support.
