Call to Order and Roll Call

President Melnick called the Regular Meeting to order at 6:30 p.m.

Communications

Board

Mr. Feld reported on the NSSED Leadership Council Meeting of December 9, 2020. NSSED has hired a space utilization consultant. Two leases will be expiring, one on the NSAE building on Revere Drive and the other on the Arbor Academy building on Lake Cook Road, and the leases will be extended. SEPTRAN is requesting that NSSED and the member districts help support their business by paying a fee during the Adaptive Pause. Negotiations are currently being conducted. If the conditions, are agreed upon, the member school districts will have to pay a portion of the monies. The member school districts can apply for reimbursement for up to 80%. The Adaptive Pause for NSSED is very similar to District 27's Adaptive Pause. NSSED will be implementing Remote Plus which, beginning January 4, 2020 will have in-person for the children with the greatest needs. They will participate in 1:1 activities. The NSSED Budget is projecting a deficit. Challenges have been COVID expenses and decreased enrollment.

Mrs. Garber Amram reported on the December 9th Policy Committee meeting. The meeting was attended by Mrs. Carlos, Mrs. Copeland and Mrs. Garber-Amram of the Board; Dr. Kroeze, Dr. Fournier, Dr. Rio, and Dr. Olson of the administration.

The Committee reviewed other Policies that reflect minor updates not requiring discussion. The "review date" will be January 2021, and they will be placed Board agenda for a first read on December 17, 2020 and approved in January.

Mrs. Garber Amram reported on the December 16th Policy Committee meeting. The meeting was attended by Mrs. Carlos, Mrs. Copeland and Mrs. Garber-Amram of the Board; Dr. Kroeze, Dr. Fournier, Dr. Rio, and Dr. Olson of the administration. The Committee met to discuss Policy 2:265 Title IX Sexual Harassment Grievance Procedure. Although the policy is largely repetitive of other policies that deal with discrimination and harassment, this policy highlights these abuses in light of Title IX, the 1972 Federal Civil Rights law expressing forbidding discrimination on the basis of sex in educational programs and activities. This new Title IX policy has cross references to eight other policies that consequently need to be updated. They are:

- a. 5:10 Equal Employment
- b. 5:20 Workplace Harassment
- c. 5:100 Staff Development
- d. 7:10 Equal Education
- e. 7:20 Harassment of Students
- f. 7:180 Bully Prevention
- g. 7:185 Teen Dating Violence

This policy will be included on the December 17, 2020 Board agenda for a First Read.

Mr. Frum presented a report on the Finance Committee Meeting of December 17, 2020. The committee discussed the current percentage of fund balance reserve and the levels of funding needed for regular operations and future capital improvement projects. Over the next five years, the District needs to complete the roof systems and HVAC replacements at each of the school buildings. Also discussed was a preliminary discussion about the potential need for future building addition space as it relates to our regular and special education classroom needs.

As an outcome of those discussions, the Committee felt it was important to gain a general understanding of our options as a school district for additional revenue generation beyond regular operations; specifically borrowing options.

Anthony Miceli, Senior Vice President, at Speer Financial, joined the Committee to present borrowing options available to us as a school district.

The committee was educated on general obligation limited tax bonds, general obligation building bonds, timing of a referendum cycle and impact of the debt obligation to tax payers.

Although it is yet to be determined what decisions the Board will need to make in the future, the Committee felt it was important to take this first step and be educated on borrowing options for Illinois school districts.

Dr. Olson presented an Assessment Update. Nationally, the state STAR results indicated learning loss in reading was not nearly as pronounced as anticipated. Learning loss in math appears substantial. District 27 did not observe any substantial learning loss in math or reading. The variation in cohort scores was within the range of typical. She added that the Terra Nova will be administered in February. Online testing will be used for grades 4-8 to address the quarantining issue. There will be reduced testing for the Survey test for grades 2-8, the InView test will be administered at grades 2 and 3 only, and the Math computation and vocabulary will be administered at grades 2 and 3 only.

Dr. Kroeze reported on the Northfield Township Special Services Program. The Special Education Directors and Superintendents have been working on the details. We will begin managing specific programs on a three-year phase-in structure. Phase I will begin in the 2021-2022 school year. At that time we will begin managing our own Early Childhood Programs for 3 and 4 year olds. NSSED will still provide ancillary services, i.e. OT and PT. The majority of the classes are in District 31 and Dr. Murphy will be hiring a coordinator to help oversee the Program requirements. Cost savings for the three districts is estimated to be a minimum of \$300,000. Everyone is pleased with the way the Program is progressing. We are anticipating increases in the tuition for NSSED this year.

Dr. Fournier reported on the Superintendent Search. The timeline is progressing as planned. Board members and Central Office staff have been interviewed by the search firm. The search firm has also spoken with various focus groups. HYA will present a *Leadership Profile Report* at the January 14, 2021 Board of Education meeting. Mrs. Melnick added that the search firm is looking at January 21, 2021 to present the candidate slate discuss the questions that the Board would ask the candidates.

Dr. Fournier reported that there was a FOIA Request from WBEZ regarding attendance and the request was responded to in the appropriate amount of time.

Financial Report

Mr. Frum presented the Financial Report. The District remains in a stable financial position. As of month end November the cumulative fund balance is at an 88% reserve level. On the revenue side of the budget, the majority of the receipts recorded are for property tax collections. We continue to receive distributions for the 2nd installment 2019 taxes. On the expenditure side of the budget, there are no unfavorable budget to actual line items to report. We have accounted for property tax refunds in November. As of month end, property tax refunds totaled \$245,431.17. On the Statement of Investments, the average rate of return for month end November was .092%.



WHEREAS, the Board of Education of School District 27 has been authorized by Sec. 20-1 of the *School Code* to create a "Working Cash Fund" for the purpose of enabling the District to have in its treasury at all times sufficient money to meet demands thereon for ordinary and necessary expenditures for corporate purposes, and

WHEREAS, the Board of Education of School District 27 has been authorized by Sec. 20-3 of the *School Code* to levy annually upon all taxable property of the District a tax, known as the "working cash fund tax," not to exceed .05 percent of full, fair cash value, as equalized or assessed by the Department of Revenue for the purpose of providing moneys for a working cash fund.



NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED, by the Board of Education of School District 27, Cook County, Illinois, as follows:

Section 1. This Board maintains a working cash fund in accordance with Article 20 of the *School Code*.

Section 2. The amount of tax levied hereby to be extended for working cash purposes will not increase the working cash fund to a total amount exceeding 85 percent of the taxes last extended for educational purposes.

Section 3. There is hereby levied for the year 2020 a special tax for working cash fund purposes in accordance with Section 20-3 of the *School Code* in the sum of \$113 to produce a tax rate not to exceed .05 percent on the value of all taxable property in the district as equalized or assessed by the Department of Revenue.
