#### Community Comments for Items on the Agenda

On behalf of the association, Ms. Kaczmarek thanked the administrators for all of their work this summer. A big thank you to the maintenance and custodial staff for all of their efforts in getting the buildings prepared for the start of school. The new front office at Wood Oaks looks great and the space utilization is much improved with the addition of a new conference room.

1. Board

• Announce the New Staff Reception with the Board of Education

Mr. Frum indicated that the reception will be held on September 22nd before the regular meeting, there will be 7 new staff members in attendance.

2. Staff

• Review of the 2022-23 COVID-19 Reopening Plan

Dr. Deiter reviewed some of the updates that have now been made to the plan which was previewed at the last meeting. These updates are in response to the recently updated guidelines. One difference is that we will no longer conduct contact tracing for unvaccinated individuals. An online learning option will still be required, so a few of our part-time teachers will be providing additional support for our younger students.

Academic lunch will be offered to help students who may need to isolate and want the extra study time. The plan, which includes COVID safety protocols, remains subject to change as health guidance evolves throughout the school year.

# • Report on Summer Success Program

Dr. Olson shared results from the satisfaction survey taken by students, parents and staff:

- 73% of students reported their teacher to be one of their favorite aspects of the program.
- 63% of students reported that reading and math activities were also a favorite aspect.
- 94% of parents surveyed said they would enroll their child again.
- 100% of staff surveyed reported being interested in teaching the program again.
- Students reported several specific ways in which they grew their literacy and math capacities this summer, including becoming better with phonics and becoming faster with math facts. Some students included testimonials about how they gained self confidence and fostered friendships.
- Parents reported being satisfied with the overall length of the program. All parents surveyed either agreed or strongly agreed that their child learned through the program.
- Anecdotally, teachers spoke about growth and engagement, and were excited for their students.

## • Enrollment Report

Dr. Deiter reported that 1,301 students are currently enrolled. An eighth section was added to first grade which has a total of 154 students. We anticipate moving accomodations for second grade next year and will continue to monitor and see if that group continues to be the highest. Another report will be given in September.
